Provide this information in the exact order listed and using the headings indicated. This Offeror shall clearly demonstrate what is being proposed for this Project;
 - B. Identify any subcontractors and/or joint ventures at the time of submission, if any, and the roles these relationships will have in the performance of the Contract. Upon MSA's request, Offerors shall make available within 24 hours the subcontractor and/or joint venture scope of work documents and/or agreement;
 - C. A completed Prime Contractor's List of All Subcontractors (Attachment N);
 - D. Resumes: Provide resumes for each proposed Key Personnel, and key subcontractors' Key Personnel; and
 - E. A completed Capacity Summary Sheet (Attachment G)."; and
- 6. Requirement 4.3.6.E was stricken, because this submission is now a required submission under Section 4.3.5, per this Addendum No.1.
